

## **YACHT RESERVATION & PAYMENT POLICIES**

- The Confirmation of a booking for individual passengers or charters with DARWIN YACHT require and are subject to the following:
- A 30% deposit per person is required within the next 8 days after a written confirmation.
- A 40% deposit per person is required as a second settlement 180 days prior to the departure of the cruise.
- Final or full payment per person is required 60 days prior to the departure of the cruise.
- Any booking under 60 days requires full payment per person.
- For last minute bookings, full payment per person is required.
- All passenger/s take full responsibility of hiring their own medical & life insurance, any accident resulting of any cause or incident during DARWIN'S itineraries will be up to the passenger/s to cover all incurring expenses such as, transfers, medical assistance, medication, ambulance, flight tickets, emergency assistance and any other related expenses, DARWIN Yacht commits itself to help organize the necessary arrangements, but under no circumstance will it be held accountable to pay any amount to the passenger/s or service providers.
- All passenger/s must inform DARWIN Yacht of any dietary restrictions or diseases that could cause death during a tour, whether it being for eating restricted meals or as a result of sickness, DARWIN Yacht cannot be held responsible if they were not notified and aware of the passenger/s medical condition.
- Dates cannot be modified, changed or moved with the objective of keeping a same rate or other means, changes to the requested dates are not accepted under any conditions, if date are no longer valid as originally requested, the passenger will lose the initial deposit/s in compliance with our terms and conditions.
- DARWIN Yacht cannot be held responsible for third parties operation whether it is during or not during the operation of its itineraries.
- All physical activities such as: snorkeling, diving, swimming, treks, walks and other activities during scheduled itineraries are the absolute responsibility of each individual passenger.
- All cabins on board of DARWIN Yacht have different dimensions and sizes as a result of it's physical structure, there is no reimbursements if any passenger/s is unhappy with his/hers assigned cabin.

- All passengers are not allowed to use any type of narcotics, drugs or exceed the consumption of alcohol on-board of the DARWIN Yacht, noncompliance with these terms will be notified by the captain & the inflicting passenger/s will be disembarked and lose the remaining portion of the itinerary/ies, no reimbursements will be provided under these circumstances.
- DARWIN Yacht itineraries are subject to change by the Galapagos National Park, Galapagos Operation, climate, governmental entities that regulate Galapagos, security and other norms to ensure the islands and passenger's safety.
- DARWIN Yacht will not provide any type of reimbursements under the following circumstances: Delays, problems and/or cancellation/s of international or domestic flights, international or national strikes, political movements, international or national governments, Climatic changes, Entities that regulate the Galapagos, noncompliance with reservation & payment policies or others.

### **YACHT CANCELLATION POLICIES**

- Please take notice of the following conditions that DARWIN Yacht will apply for any cancellation in full effect:
- DARWIN Yacht will only accept cancellations 120 days prior to the departure of the cruise, a reimbursement of 95% per person will be provided, the remaining 5% will apply as a surcharge to cover administrative costs.
- 119 to 105 days prior to the departure of the cruise, DARWIN Yacht will charge a 30% penalty fee over the total amount of the cruise cost per person.
- 104 to 93 days prior to the departure of the cruise, DARWIN Yacht will charge a 70% penalty fee over the amount of the cruise cost per person.
- 92 days prior to the departure of the cruise, DARWIN Yacht will not reimburse any amount of money paid by the acting travel agent, passenger/s or any other person/entity, the passenger/s will lose the 100% paid to Darwin Yacht as a cancellation fee.
- For last minute bookings, DARWIN Yacht will not reimburse any amount of money paid by the acting travel agent, passenger/s or any other person/entity, the passenger/s will lose the 100% paid to Darwin Yacht as a cancellation fee.
